GENERAL NOTES ON MEMBERSHIP

1	Each yearly subscription fee shall be payable on Jan 1st of every year. The validity for each membership is 12 months. Memberships applied in the middle of the year will be charged pro-rata of the balance-period in the calendar-year. There will be no-refund for members who chose to cancel their membership before the end of the calendar-year, including for reasons of leaving the country. Memberships can however be transferred to a different individual within the same organisation.
2	For members who fail to pay their subscription fee within 3 months of its due date (Mar 31st), their membership will automatically be terminated. If they want to resume their membership after it is terminated, a penalty of 3000 Ksh will be imposed.
3	A downgrade of membership is feasible but it is subject to an administration cost of Ksh 1000.
